After signing into the portal, all reporting forms appropriate to your lab certification will be accessible. You will be able to enter your test results into the forms and submit to CCIL through the portal. CCIL's instructions for testing will also be available within the portal, for your convenience.

All certified asphalt and aggregate laboratories will be notified by email when the electronic reporting forms are delivered into your portal.

Completed forms submitted by email or fax cannot be utilized and will **NOT** be accepted.
